Exclusions

1. War, invasion, act of foreign enemies, hostilities, civil war, rebellion, revolution, insurrection, military or usurped power.
2. Martial Law or stage of siege.
3. Terrorism.
4. Fits, hernia, venereal disease, AIDS, pregnancy, childbirth, miscarriage, confinement or any complications, drugs, suicide, self-inflicted injury.
5. Insanity or mental illness.
6. Flying as a pilot or crew member in any aircraft.
7. Steeple chasing, winter sports, martial arts and racing (other than on foot).
8. Mountaineering, polo and professional sports.
9. Aerial Sporting Activities.
10. Radiation or contamination by radioactivity.

Personal Accident Insurance Claim

Documents to be Submitted:

1. Completed 'Statement & Particular of Claim'.
2. Original copy of Medical Report (*page 3 & 4 for bill more than RM300*).
3. Original medical bills and receipt (*duplicate or photocopy is not acceptable*).
4. Photocopy of student ID card.
5. Photocopy of student Passport or IC.
6. Explanation letter (*why, when, what happened*)- *please insert*.
7. Completed 'E-Payment' form and print bank statement.
8. Copy of Police Report. (*if motor vehicle accident*).
9. Copy of claimant's driving license (*If motor vehicle accident*)

Reimbursement for Death Claim

Documents to be Submitted:

1. Completed 'Statement & Particular of Claim'
2. Copy of Police Report.
3. Copy of Death Certificate.
4. Copy of detailed Postmortem Report.
5. Photocopy of student ID card.
6. Copy of Burial / Cremation Permit.
7. Completed 'E-Payment' form and bank statement.
8. Copy of deceased driving license (*if motor vehicle accident*).
9. Beneficiary passport/IC copy, marriage certificate & deceased birth certification.

Important Information to Note

1. Any medical visit or treatment **must be assessed by a qualified and registered medical practitioner** (MBBS background doctor).
2. Any claim for any visit or treatment done by non-qualified and non-registered medical practitioner is **not acceptable**.
3. The student will have to **pay first and claim later**.
4. The personal accident and medical report form can be downloaded at the Campus Central Portal.
5. Validity of claim submission **within 1 month after the first treatment**.
