


LEVEL UP TO AN UNDERGRADUATE OR POSTGRADUATE DEGREE WITH JUST YOUR WORK EXPERIENCE

Accreditation of Prior Experiential Learning (APEL) provides an alternative pathway for adults who lack formal education to leverage their experience for career development. Through APEL, they can gain access to undergraduate or postgraduate programmes (APEL.A), or to shorten their study duration (APEL.C).

The systematic process identifies, documents, and assesses prior experiential learning from the aspects of knowledge, skills, and attitudes. This determines the extent to which an individual has achieved the desired learning outcomes, for their goal of accessing a programme of study and/or award of credits.



GLOSSARY

FORMAL LEARNING

Intentional learning or a programme of study delivered within an organised and structured context (pre-school, primary school, secondary school, technical college and university), which may lead to formal recognition or a recognised qualification.

INFORMAL LEARNING

Learning which takes place continuously through life and work experiences. It is often unintentional learning.

NON-FORMAL LEARNING

Learning that takes place alongside the mainstream systems of education and training. It may be assessed but does not normally lead to formal certification.

APTITUDE TEST

A formal examination that applicants are required to pass. The purpose is to assess the competence and readiness of the applicant to pursue tertiary education. Test areas include Numerical Literacy, Bahasa Malaysia Language, English Language, and General Knowledge, Critical Thinking and Digital Literacy.

CHALLENGE TEST

A proctored standard test to assess if you have achieved the module learning outcomes. It can be in the form of a written test, oral examination and/or performance assessment, depending on the nature and discipline of the module, as well as individual module learning outcome.

PORTFOLIO

A compilation document of previous experience including formal, informal and non-formal learning. The portfolio must be prepared in such a way that it allows you to demonstrate that the learning acquired is relevant.

ACCREDITATION OF PRIOR EXPERIENTIAL LEARNING FOR ACCESS (APEL.A)

APEL.A provides an opportunity for individuals with working experience but lack formal academic qualifications to pursue tertiary education at Higher Education Institutions. The APEL.A assessment, made up of the Aptitude Test and Portfolio Assessment components (refer to Glossary), will be on formal learning, informal learning and non-formal learning that has been attained over the years by the learner.

WHO CAN APPLY

For Bachelor's Degree:

- Malaysians
- More than 21 years of age in the year of application
- Possess relevant work experience*

For Master's Degree:

- Malaysians
- At least 30 years of age in the year of application
- Possess at least STPM / Diploma / equivalent qualifications (or those with higher qualifications e.g. Advanced Diploma, Graduate Certificate, Graduate Diploma)
- Possess relevant work experience*
- * Relevant work experience will be calculated starting from the minimum age of 18 years.



Why should I apply for APEL.A at Taylor's University?

What are the application criteria for APEL.A?

Bachelor's Degree programme

For admission into the Bachelor's Degree programme, candidates must be Malaysian, at least 21 years of age in the year of application and have relevant work experience.

Master's Degree programme

For admission into the Master's Degree programme, candidates must be Malaysian and at least 30 years of age in the year of application. The candidate must also have STPM or Diploma or other recognized equivalent qualifications and have relevant work experience.

Can I apply to any programme at Taylor's University via APEL.A?

For now, APEL.A assessment at Taylor's is opened for TWO levels of admissions which are:

- i) Admission to the Bachelor's Degree programme (APEL T-6); and
- ii) Admission to the Master's Degree programme (APEL T-7).

Can I get any refund if my assessment is not successful?

No, all fees paid are non-refundable

What are the areas assessed in the Aptitude Test?

Aptitude test is a formal examination that applicants are required to pass. The purpose is to assess the competence and readiness of the applicant to pursue tertiary education.

What is Portfolio Assessment?

Portfolio is compilation document of previous experience including formal, informal and non-formal learning. The portfolio must be prepared in such a way that it allows you to demonstrate that the learning acquired is relevant.

Are the applicants allowed to apply their studies to other Higher Education Provider (HEP) after passing the APEL.A assessment at Taylor's University?

No. Applicants who have obtained MQA's APEL.A certificate from Taylor's University can only further their studies at Taylor's University.

I have applied for APEL.A through MQA website and selected Taylor's University for assessment. What should I do next?

Applicant will receive an email automatically generated by the system after registering on the MQA APEL.A Portal. Next, the applicant needs to re-register with Taylor's University via the link provided in the email.

I am interested in taking the APEL.A assessment and continuing my studies at Taylor's University. When is the right time I should apply for APEL.A?

Applicants are advised to submit the APEL.A application at least SIX (6) months before the date of admission to the programme at Taylor's University.

What is the validity period of APEL.A certificate?

APEL.A Certificate is valid for 5 years only. Applicant may submit a new application for APEL.A assessment after the APEL.A certificate expires.

ACCREDITATION OF PRIOR EXPERIENTIAL LEARNING FOR CREDIT AWARD (APEL.C)

APEL.C is the award of credits for prior experiential learning towards a module in an accredited programme. The credit award is granted on the basis of the knowledge and skills acquired through informal and non-formal learning. The maximum percentage of credit transfer is 30% of the minimum graduating credits.

- Applicants who are registered students of Taylor's in the applicable programme
- Applicants with relevant informal and/or non-formal learning experience in the module(s) applied for APEL.C award



What is the age limit to apply for APEL.C?

There is no age requirement or limit to apply.

What is the maximum percentage of credit transfer allowed?

The maximum percentage of credit transfer is 30% of the minimum graduating credits. This percentage is in addition to the credit transfer provision, i.e. 30% based on the existing formal credit transfer policy.

Is APEL.C applicable for all modules?

According to the Guidelines to Good Practices: Accreditation of Prior Experiential Learning for Credit Award issued by the Malaysian Qualifications Agency (MQA), APEL.C is applicable for all modules (including internship), except for final-year project-based modules and dissertations. At Taylor's, currently APEL.C is applicable for selected programme modules. View the list of modules on our website or get in touch with us for more info.

How is APEL.C assessed?

The assessment depends on the experiential learning accumulated by the student over the years. Methods of assessment that can be used are the Challenge Test or Portfolio Submission.

What is the difference between the Challenge Test and Portfolio Submission?

The Challenge Test is a proctored standard test to assess if you have achieved the module learning outcomes. It can be in the form of a written test, oral examination and/or performance assessment, depending on the nature and discipline of the module, as well as individual module learning outcome. The Portfolio Submission requires you to prepare a compilation document of previous experience including formal, informal and non-formal learning. The portfolio must be prepared in such a way that it allows you to demonstrate that the learning acquired is relevant.

When can I submit a formal application?

You may apply for APEL.C any time after you have enrolled as a Taylor's student and accepted the offer. However, you are advised to submit the APEL.C application before or during the first semester of study. Kindly take note that APEL.C application is open in January, April, July, and October. Please refer to the APEL Unit for the submission deadline.

Can I get any refund if my assessment is not successful?

No, all fees paid are non-refundable.

Will APEL.C credit transfer contribute to my CGPA?

No. The credit award (without any grades) will appear in the transcript of the student as 'CT(APEL)'.
