Important Notes

- 4. All fees are payable in advance. Full settlement of first semester fees is required upon enrolment.
 For subsequent semesters, full settlement of fees must be made on or before the commencement of that semester.
- 5. Additional fees may be incurred to meet academic/Ministry of Higher Education of Malaysia requirements (Bahasa Kebangsaan A is compulsory for Malaysians without a credit in SPM Bahasa Melayu).
- 6. Students in selected undergraduate programmes may choose to take Master-level modules as electives.

 These modules are part of the Integrated Bachelor-Master Programme (IBMP) pathway and will be charged according to the postgraduate credit hour fee.
- 7. The enrolment fee is strictly non-refundable except in the event student cannot be accepted due to non-fulfilment of minimum entry requirements (this does not include provisional/ conditional offer).

 An administrative fee will be charged for semester fee refunds resulting from voluntary withdrawal prior to the commencement of the semester.
- 8. The tuition fees shown are based on the minimum credit hours required for students to complete the programme. Any additional credit hours are subject to extra charges.
- 9. Multiple payment options are available:
 - Taylor's Pay is a secure online payment service available through Taylor's Campus Central Portal and Taylor's Mobile App. It enables real-time fee payments with seamless account integration and instant updates to your payment records.
