- Additional fees may be incurred to meet academic/Ministry of Higher Education of Malaysia requirements (Bahasa Kebangsaan A is compulsory for Malaysians without a credit in SPM Bahasa Melayu).
- Students in selected undergraduate programmes may choose to take Master-level modules as electives.
These modules are part of the Integrated Bachelor-Master Programme (IBMP) pathway and will be charged according to the postgraduate credit hour fee.
- The enrolment fee is strictly non-refundable except in the event student cannot be accepted due to non-fulfilment of minimum entry requirements (this does not include provisional/ conditional offer).
An administrative fee will be charged for semester fee refunds resulting from voluntary withdrawal prior to the commencement of the semester.
- The tuition fees shown are based on the minimum credit hours required for students to complete the programme. Any additional credit hours are subject to extra charges.
